

North Area Junior Hockey Association Selection Trials for 2011 Representative Season

North Area representative selection trials for the 2011 season will be held as follows:

U11 Boys 7:00am – 8:30am Sunday 22 August 2010, Cintra
U13 Boys 8:30am – 10:30am Sunday 22 August 2010, Cintra
U15 Boys 10:30am – 12:30pm Sunday 22 August 2010, Cintra

U11 Boys 7:00am – 8:30am Sunday 29 August 2010, Cintra
U13 Boys 8:30am – 10:30am Sunday 29 August 2010, Cintra
U15 Boys 10:30am – 12:30pm Sunday 29 August 2010, Cintra

Trials will consist of a warm up, skill session, games, & goalie assessment. Cost of trials will be \$10 per player (2 sessions) plus \$5 per training session if you make the NAJHA teams (max \$15 per player, covers ground fees).

Two NAJHA teams will be selected in each of the above age groups. These teams proceed to the SJHA trials.

Teams selected by the NAJHA will train prior to the SJHA as follows:

U11 Boys 8:00am - 9.30pm 5 September 2010, Cintra
U13 Boys 9:30am - 11:00am 5 September 2010, Cintra
U15 Boys 11:00am - 12:30pm 5 September 2010, Cintra
(shadows may train but will not attend SJHA trials)

U11 Girls, U13 Girls, U15 Girls & U17 Boys progress direct to SJHA trials, they do not need to trial for NAJHA first.

U15 Boys Sun 12 Sept 2010 Cintra (2:00pm – 5:00pm), Sun 19 Sept 2010 Cintra (2:00pm – 5:00pm)

U11 Girls, U13 Girls, U15 Girls and U17 Boys will trial in February 2011 (dates yet to be received from SJHA)

Players who proceed to SJHA selection trials will be asked to provide a commitment fee prior to the commencement of the trial. This will be refunded on the day for players who are not selected.

If you wish to trial for 2011 SJHA rep selection all Boys & Girls U11, U13, U15, U17 must supply their names, address, DOB, email address, playing position preference 1 & 2 by email to bopaiah@iinet.net.au before **13th August 2010.**

* Please note that SJHA trials are scheduled over two sessions. At the close of the first session a squad including shadows will be announced. This squad will proceed to trial on the second nominated session. Teams will be announced at the close of this second session.
